



# 2024 KANSAS CUP Entry Form



The 31st annual Kansas Cup will be contested from April through October, 2024 by Central Links Golf member clubs that submit their timely entry form. Entry deadline is **April 12, 2024**. The divisional assignments will be published on approximately April 19, 2024.

The Kansas Cup is a team competition modeled after the popular Ryder Cup. Each team is comprised of sixteen players. Matches are conducted on the home course of one of the teams, with home-and-home round robins within designated divisions. Teams advancing to the single-elimination playoff bracket with matches to determine an overall champion.
